The ornamental design for a voice assisted digital interface device, as shown and described.

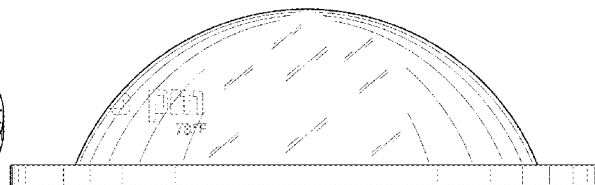
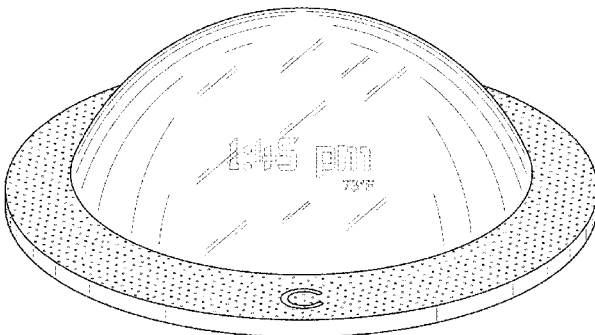
**DESCRIPTION**

FIG. 1 is a perspective view of a voice assisted digital interface device, showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The broken dot-dash lines showing the time depict an environmental state of use and form no part of the claimed design; while all other broken lines depict portions of the voice assisted digital interface device that form no part of the claimed design.

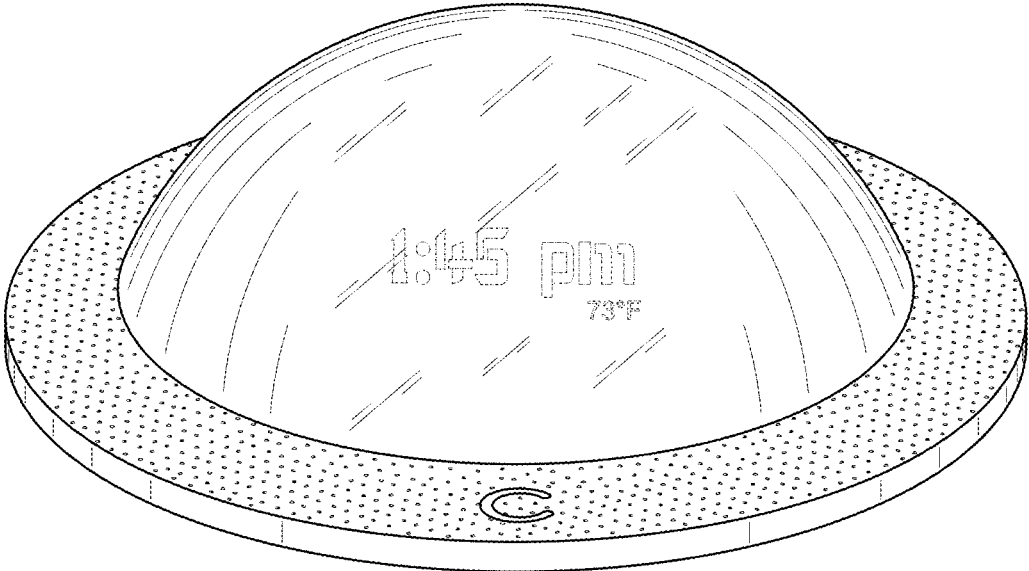

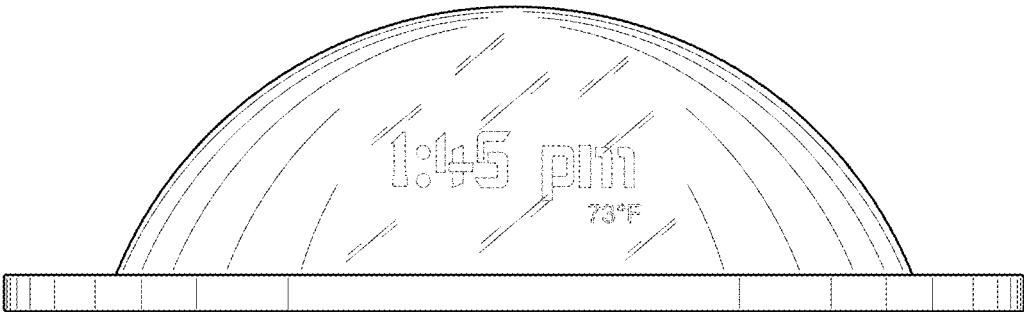

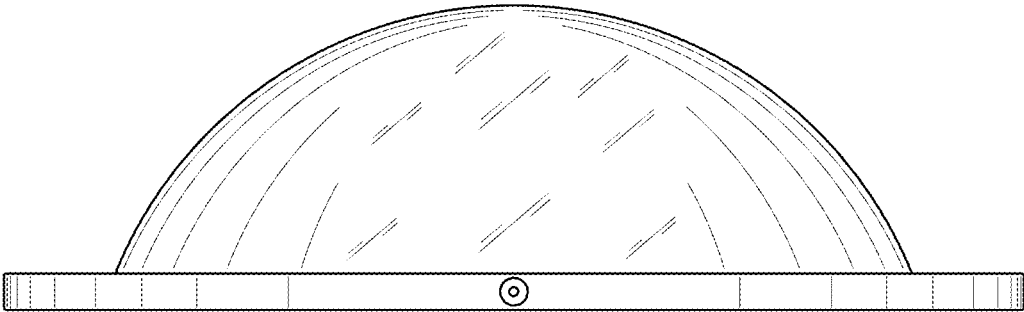

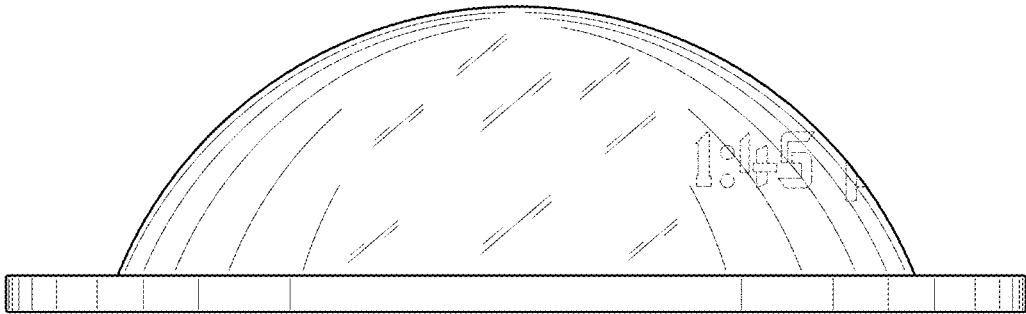

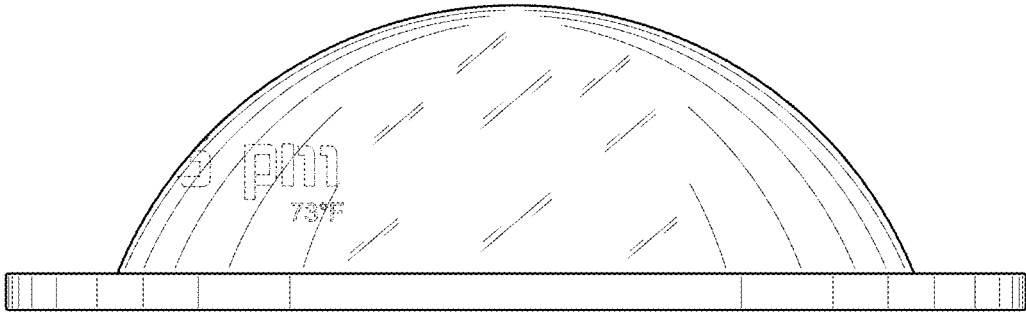

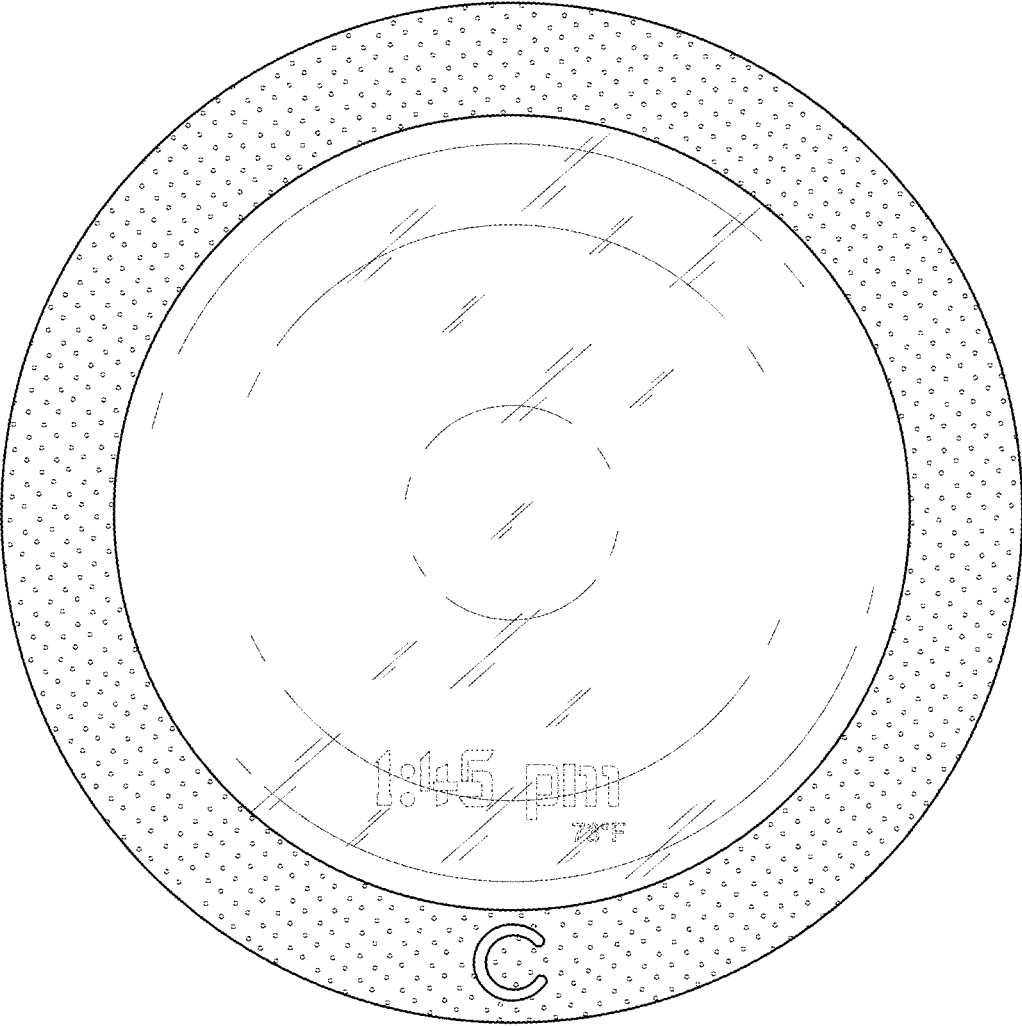
